A RESOLUTION OF THE HOUSING AUTHORITY OF  
THE CITY OF SAN DIEGO RECOMMENDING APPROVAL  
OF THE FY03 ANNUAL AGENCY PLAN AND AUTHORIZING  
THE CHIEF EXECUTIVE OFFICE TO TRANSMIT THE PLAN  
TO THE DEPARTMENT OF HOUSING & URBAN DEVELOPMENT.

WHEREAS, local housing authorities are required by the Department of Housing and Urban Development [HUD] to submit five-year and annual agency plans [the Plans]; and

WHEREAS, the Quality Housing and Work Responsibility Act outlines the requirements and the contents for each plan submitted; and

WHEREAS, the Plans include the policies which guide the administration of the Housing Authority's Public Housing and Section 8 programs; and

WHEREAS, the Annual Agency Plan provides information on what the Housing Authority will do in the next fiscal year toward achieving the goals and objectives indicated in its five-year goals and objectives; and

WHEREAS, the Plans are prepared cooperatively with residents serving on the San Diego Housing Commission's Resident Advisory Board comprised of both Public Housing residents and Section 8 participants; and

WHEREAS, Housing Commission staff certifies that the FY03 Agency Plan is consistent with the City's Consolidated Plan; and

WHEREAS, a notice of public hearing in a newspaper of general circulation in the City has been published to the effect that a public hearing was to be held on Wednesday, February 20, 2002, and that the public was provided with a 45 day period to review the draft plan, prior to the public hearing, for its impact upon the housing assisted community; NOW THEREFORE,

BE IT RESOLVED, by the Housing Authority of the City of San Diego as follows:

1. Finding and Determination. The Housing Authority approves the FY03 Annual Agency Plan and finds the above recitals, and each of them, true and correct. The Authority determines that it is necessary as required by the Department of Housing and Urban Development to authorize the Chief Executive Office of the San Diego Housing Commission to transmit the FY03 Annual Agency Plan.
2. Declaration of Official Intent. This resolution is being adopted by the Authority solely for purposes of authorizing the Chief Executive Office of the San Diego Housing Commission to transmit the FY03 Annual Agency Plan.
