WHEREAS, the Agency has amended the Agreement by a First Amendment to Agreement on October 6, 1998, by Resolution No. R-02896; Second Amendment to Agreement on July 20, 1999, by Resolution No. R-03016; Third Amendment to Agreement on February 14, 2000, by Resolution No. R-03124; and Fourth Amendment to Agreement on July 31, 2000, by Resolution No. R-03195; and

WHEREAS, in order to carry out and implement the Redevelopment Plan the Agency proposes to further amend the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Executive Director of the Agency, or designee, is authorized and empowered to execute, for and

on behalf of the Agency, the Fifth Amendment to Agreement with Daley and Heft for special

legal counsel services in the Centre City Redevelopment Project, under the terms and conditions

set forth in the Fifth Amendment to the Agreement, a copy of which is on file in the Office of the

Secretary to the Agency as Document No. D-03250.

BE IT FURTHER RESOLVED, that an additional expenditure in an amount not to

exceed \$750,000 is authorized, solely and exclusively, for the purpose of providing funds for the

amended agreement with Daley and Heft, increasing the original contract amount to a total of

\$3,091,100.
