A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE FIRST AMENDMENT TO EXCLUSIVE NEGOTIATION AGREEMENT WITH EAST VILLAGE DEVELOPMENT SAN DIEGO, LLC.

WHEREAS, the Agency and Developer propose (pursuant to the terms and conditions of the First Amendment to Exclusive Negotiation Agreement) to amend the Agreement, to add property and to increase the amount of development which is subject to negotiation, to extend the period of negotiations, and to make other changes deemed appropriate by the parties; and

WHEREAS, the Developer has submitted to the Agency copies of the proposed First Amendment to Exclusive Negotiation Agreement [First Amendment] in a form desired by the Developer; and

WHEREAS, the Agency has duly considered all of the terms and conditions of the proposed First Amendment and believes that the conditions contained in the proposed First Amendment are in the best interest of the City and the health, safety, morals and welfare of its residents, and in accord with the public purposes and provisions of applicable State and local law

and requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

That the proposed First Amendment to Exclusive Negotiation Agreement and the 1.

terms and conditions thereof are approved.

That the Executive Director of the Agency, or designee, is authorized to execute 2.

the First Amendment to Exclusive Negotiation Agreement for and on behalf of the Agency. A

copy of the First Amendment to Exclusive Negotiation Agreement is on file in the office of the

Secretary to the Agency as Document No. D-03251.

3. That the Executive Director of the Agency, or designee, is authorized, for and on

behalf of the Agency, to sign all documents necessary and appropriate to carry out and

implement the First Amendment to Exclusive Negotiation Agreement and to administer the

Agency's obligations, responsibilities, and duties to be performed under the First Amendment.
