A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING A SEVENTH AMENDMENT TO THE AGREEMENT WITH DALEY & HEFT FOR SPECIAL LEGAL COUNSEL SERVICES IN THE CENTRE CITY REDEVELOPMENT PROJECT.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Centre City Redevelopment Project [Project] in downtown San Diego; and

WHEREAS, the Agency has entered into an agreement for special legal counsel services for the Centre City Redevelopment Project with Daley & Heft; approved by the Agency on September 12, 1995, by Resolution No. 2553 [Agreement]; and

WHEREAS, the Agency has amended the Agreement by a First Amendment to Agreement on October 6, 1998, by Resolution No. R-02896; Second Amendment to Agreement on July 20, 1999, by Resolution No. R-03016; Third Amendment to Agreement on February 14, 2000, by Resolution No. R-03124; Fourth Amendment to Agreement on July 31, 2000, by Resolution No. R-03195; and Fifth Amendment to Agreement on October 24, 2000, by Resolution No. R-3250; and the Sixth Amendment to Agreement on March 29, 2001, by Resolution No. R-03303; and

WHEREAS, in order to carry out and implement the Redevelopment Plan the Agency proposes to further amend the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Executive Director of the Agency, or designee, is authorized and empowered to execute for and

on behalf of the Agency, the Seventh Amendment to Agreement with Daley and Heft for special

legal services in the Centre City Redevelopment Project, under the terms and conditions set forth

in the Seventh Amendment to the Agreement, a copy of which is on file in the office of the

Secretary to the Agency as Document No. D-03370.

BE IT FURTHER RESOLVED, that an additional expenditure in an amount not to

exceed \$1,505,000 is authorized, solely and exclusively, for the purpose of providing funds for

the amended Agreement with Daley and Heft, thereby increasing the original contract amount to

a total \$5,331,100.
