ADOPTED ON FEBRUARY 26, 2002

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION TO ENTER INTO A THIRD AMENDMENT TO THE AGREEMENT WITH PROJECT DESIGN CONSULTANTS FOR ASNEEDED ENVIRONMENTAL CONSULTING SERVICES IN THE CENTRE CITY AND HORTON PLAZA REDEVELOPMENT PROJECTS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plans for the Centre City and Horton Plaza Redevelopment Project Areas [Project Areas]; and WHEREAS, the Centre City Development Corporation [CCDC] is responsible for implementing redevelopment projects in the Project Areas; and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency proposes to pay for as-needed environmental consulting services; and

WHEREAS, on February 2, 2000, CCDC previously entered into an Agreement [Agreement] for as-needed environmental consulting services with Lettieri-McIntyre [Contractor] (which later merged with Project Design Consultants) in the amount of \$50,000, a copy of the Agreement is on file in the Office of CCDC; and

WHEREAS, on December 8, 2000, the Agreement was amended to change the name of

the Contractor from Lettieri-McIntyre to Project Design Consultants due to a merger; a copy of

the First Amendment to Agreement is on file in the Office of CCDC; and

WHEREAS, on or about June 29, 2001, a Second Amendment to Agreement was entered

into with Project Design Consultants to increase the maximum amount by \$50,000, for a total

contract amount not to exceed \$100,000; a copy of the Second Amendment to Agreement is on

file in the Office of CCDC; and

WHEREAS, the Agency and Project Design Consultants wish to enter into a Third

Amendment to the Agreement by increasing the maximum compensation provided for as-needed

environmental consulting services by \$35,000, increasing the total contract amount to \$135,000;

NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Executive Director of the Agency, or designee, is authorized and

empowered to prepare and execute, for and on behalf of the Agency, a Third Amendment to the

Agreement with Project Design Consultants for as-needed environmental consulting services, to

provide for an increase in the amount of compensation in an amount not to exceed \$35,000, for a

total contract amount not to exceed \$135,000. A copy of the Third Amendment to the

Agreement, when executed, shall be placed on file in the Office of the Secretary to the Agency

as Document No. D-03436.

2. That this amendment adds a total of \$35,000 to the original contract amount (as

amended); thereby increasing the compensation of the Agreement to a total amount not to exceed

one hundred thirty-five thousand dollars (\$135,000).
