A RESOLUTION OF THE REDEVELOPMENT AGENCY OF
THE CITY OF SAN DIEGO APPROVING THE RELOCATION
PLAN FOR THE PASEO AND RELIGIOUS CENTERS
PROJECTS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the College Community Redevelopment Project Area [Project Area]; and

WHEREAS, Disposition and Development Agreements [DDA] between the Agency and the San Diego State University Foundation [Foundation] for The Paseo Mixed Use Project [Paseo] and the Religious Centers Project [Religious Centers] are expected to be executed in June 2005; and


WHEREAS, the Relocation Plan identifies all of the possible residential and non-residential displaces within the footprint of The Paseo and Religious Centers and describes the benefits which will be afforded the displaces in accordance with State Relocation Law and the State Relocation Assistance Guidelines; and

WHEREAS, the Relocation Plan was sent in a general mailing to all residents and property owners within the footprints of both projects; made available for public review at the Agency's office, Agency's website and Foundation's offices; and presented to the College

Community Project Area Committee as well as the College Area Community Council; NOW
