A RESOLUTION OF THE REDEVELOPMENT AGENCY OF  
THE CITY OF SAN DIEGO APPROVING THE  
REPLACEMENT HOUSING PLAN FOR THE PASEO AND  
RELIGIOUS CENTERS PROJECTS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] shall adopt by resolution a replacement housing plan not less than thirty days prior to the execution of an agreement for acquisition of real property, or the execution of an agreement for the disposition and development of property, which agreement could lead to the destruction or removal of dwelling units from the low- and moderate-income housing market; and


WHEREAS, Disposition and Development Agreements [DDA] between the Agency and the San Diego State University Foundation [Foundation] for The Paseo Mixed Use Project [Paseo] and the Religious Centers Project [Religious Centers] are expected to be executed in June 2005, at least thirty days after the Replacement Housing Plan has been adopted by the Agency; and

WHEREAS, the Replacement Housing Plan was prepared in accordance with California Health and Safety Code section 33413 which requires the Agency to replace, within four years, any dwelling unit housing persons and families of low or moderate income that are destroyed or removed; and

WHEREAS, the Replacement Housing Plan was made available for public review on the Agency's website; released to the public for comment on January 28, 2005; and presented to the College Community Project Area Committee on February 1, 2005; NOW THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that it approves the Replacement Housing Plan for The Paseo and Religious Centers Projects, a copy of which is on file in the Office of the Secretary to the Agency as Document No. D- 03875.


