A RESOLUTION OF THE REDEVELOPMENT
AGENCY OF THE CITY OF SAN DIEGO APPROVING
THE RELOCATION PLAN FOR ISLAND-MARKET CENTRE
PROJECT.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Centre City Redevelopment Project Area [the Project]; and

WHEREAS, the Centre City Development Corporation [CCDC] is responsible for implementing redevelopment in the Project; and

WHEREAS, the Disposition and Development Agreement [DDA] and the Owner Participation Agreement [OPA] between the Agency and Oak Shelter Systems, LLC for the Island-Market Centre Project was approved by the Redevelopment Agency on September 14, 2004; and


WHEREAS, the Relocation Plan identifies all of the possible residential and non-residential displaces within the footprint of Island-Market Centre Project and describes the benefits which will be afforded the displaces in accordance with State Relocation Law and the State Relocation Assistance Guidelines; and

WHEREAS, the Relocation Plan was sent in a general mailing to all residents and property owners within the footprint of the project; made available for public review at the

Corporation's office, and presented to the Centre City Advisory Committee and the Project Area Committee; NOW THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that it approves the Relocation Plan for Island-Market Centre Project, a copy of which is on file in the Office of the Secretary to the Agency as Document No. D- 03888.
