A RESOLUTION OF THE REDEVELOPMENT AGENCY
OF THE CITY OF SAN DIEGO APPROVING THE
RELOCATION PLAN FOR THE PROPOSED REDEVELOPMENT
OF THE PROPERTY LOCATED AT HILLTOP DRIVE
AND EUCLID AVENUE.

WHEREAS, the Redevelopment Agency of the City of San Diego is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Central Imperial Redevelopment Project Area (Central Imperial); and

WHEREAS, the Southeastern Economic Development Corporation (SEDC) is responsible for implementing redevelopment in Central Imperial; and


WHEREAS, the Relocation Plan identifies all of the possible residential displaces within the footprint of the property located at Hilltop Drive and Euclid Avenue and describes the benefits which will be afforded the displaces in accordance with California Redevelopment Law; and

WHEREAS, the Relocation Plan was sent in a general mailing to all residents and property owners within the footprint of the property; made available for public review at SEDC's office and the Malcolm X Library, and presented to the Central Imperial Project Area Committee and the SEDC Board of Directors; NOW, THEREFORE,
