A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE APPROPRIATION AND EXPENDITURE OF \$30,000 FROM THE NORTH BAY REDEVELOPMENT PROJECT AREA SERIES 2000 BOND PROCEEDS AND THE TRANSFER OF THE FUNDS TO CAPITAL IMPROVEMENT PROGRAM BUDGET NO. 53-037.0.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the North Bay Redevelopment Project Area; and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency proposes to pay for part of the demolition of the Consolidated Aircraft Truck Crossing Bridge, which was constructed in 1942 to carry parts and equipment from the manufacturing plants on the east side of Pacific Highway to the main Consolidated Aircraft manufacturing/assembly plant alongside Lindbergh Field; and

WHEREAS, the public has never had access to the bridge and it has not been used in decades; and

WHEREAS, the bridge was listed by the California Department of Transportation [Caltrans] for mandatory seismic retrofit or demolition; and

WHEREAS, the demolition of the bridge was initially funded 20-percent by Caltrans and 80-percent by the Federal Highway Administration [FHWA] Transportation Equity Act for the 21st Century [TEA 21]; and

WHEREAS, as of January 2003, the State had withdrawn its 20-percent contribution due to a reduction in the budget for Caltrans; however, the City is still responsible for the maintenance and safety of the bridge and the lack of State funds does not release the City from these responsibilities; and

WHEREAS, on July 29, 2003, the Redevelopment Agency approved the appropriation and expenditure of \$100,000 and the Council and Agency made certain findings with respect to the payment of funds for the demolition of the Bridge; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Agency approves the appropriation and expenditure of \$30,000 from the North Bay Redevelopment Project Area Series 2000 Bond Proceeds, and the transfer of the funds to Capital Improvement Program Budget No. 53-037.0.

2. That the information contained in LDR Project No. 14960 (SCH Number 2003091093) has been completed in compliance with the California Environmental Quality Act and State CEQA Guidelines is certified, and that said Mitigated Negative Declaration reflects the independent judgment of the City of San Diego as Lead Agency. Stating for the record that the

final Mitigated Negative Declaration has been reviewed and considered prior to approving the project. Adopting the Mitigation, Monitoring and Reporting Program.
