A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AMENDING THE ANNUAL PROGRAM BUDGET PREVIOUSLY ADOPTED FOR FISCAL YEAR 2006-2007 INCREASING THE HORTON PLAZA REDEVELOPMENT PROJECT BUDGET BY \$1.5 MILLION AND AUTHORIZING THE EXPENDITURE OF UP TO \$1.5 MILLION FOR THE BARRIO LOGAN COMMUNITY PLAN UPDATE.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Horton Plaza and Barrio Logan Redevelopment Project areas of San Diego, and

WHEREAS, the Centre City Development Corporation (CCDC) has been authorized to administer the redevelopment projects in the Centre City and Horton Plaza Redevelopment Project Areas and the City of San Diego Redevelopment Division has been authorized to administer the Barrio Logan Redevelopment Project Area, and

WHEREAS, the Agency approved the Fiscal Year 2007 Redevelopment Agency Budget on May 31, 2006, a copy of which is on file in the office of the secretary to the Agency as Document No.: D-04027, and

WHEREAS, the Barrio Logan Planned District Ordinance was adopted on July 5, 1983 to provide tailored zoning for the community, and

WHEREAS, the Barrio Logan Redevelopment Plan was adopted in May of 1991 for a portion of Barrio Logan, and

WHEREAS, the community of Barrio Logan faces numerous challenges, including: land use conflicts created by an outmoded land use pattern; excessive trucking activity along residential streets and near a school; deficient public facilities and infrastructure; brownfield and toxic waste issues; and a lack of affordable housing, and

WHEREAS, the City Planning and Community Investment Department desires to commence work on an update of the Barrio Logan/Harbor 101 Community Plan, Zoning Program and Redevelopment Plan to address these issues,

WHEREAS, funds are necessary to support the staff and consultant work required to complete the update, and

WHEREAS, funds are available in the Horton Plaza Redevelopment Project Area for the purpose of supporting the Barrio Logan Community Plan Update, NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego:

- 1. That the Executive Director or designee is authorized to amend the Horton Plaza Redevelopment Project Fiscal Year 2007 Budget by increasing the Horton Plaza Budget for the payment of costs associated with the update to the Barrio Logan Community Plan in the amount of \$1.5 million and authorizes the expenditure of up to \$1.5 million for such purposes funded by disposition proceeds from the Horton Plaza Project Area, Fund 98410.
- 2. That approval of this amendment constitutes authority for the expenditure of funds by CCDC in Fiscal Year 2006-2007 for the Barrio Logan Community Plan update provided that funds are available from disposition proceeds.
  - 3. That the City Auditor/Comptroller is hereby authorized:

- a. To establish the necessary accounts.
- b. To appropriate and to allot all monies available in each project fund up to the amount of revenues available in each project fund.
- 4. That the City Auditor/Comptroller is hereby authorized to carry forward any unexpected balance remaining in each budgetary account at the end of each fiscal year into the next fiscal year as a continuing appropriation, subject to amendment by the Agency.
- 5. That the President of CCDC, or designee, is hereby authorized to expend funds from the Horton Plaza redevelopment project for the payment of costs associated with the update of the Barrio Logan Community Plan.
- 6. That the President of CCDC, or designee, is hereby authorized to request the City Auditor and Comptroller to make budgetary transfers between the line items and object accounts within each project fund.
- 7. That the Agency authorized the City Auditor/Comptroller, upon the request of CCDC, to transfer or loan funds between sub-projects within a project, provided that such transfers or loans do not increase or decrease the total project budgets or result in a use of such funds which would be inconsistent with the permitted uses of such funds.
- 8. That in the event the Agency desires to issue bonds, notes, or other instruments of indebtedness of the Agency to carry out redevelopment projects, then any indebtedness of the Agency to the City of San Diego, including any interest accrued thereon, shall be deemed not to be a first pledge of tax increment allocations received by the Agency pursuant to California Health and Safety Code Section 33670; and any indebtedness of the Agency to the City of San Diego, including any interest accrued thereon, shall be subordinate to any pledge of tax

increment to bondholders or the holders of other such	ch instruments of indebtedness.
