A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO REGARDING THE PUBLIC HEARING TO REVIEW THE REDEVELOPMENT PLANS AND CORRESPONDING IMPLEMENTATION PLANS FOR THE CROSSROADS AND NORTH BAY REDEVELOPMENT PROJECT AREAS AND TO EVALUATE THE PROGRESS OF THE REDEVELOPMENT PROJECTS.

WHEREAS, the Redevelopment Agency of The City of San Diego [the "Agency"] is engaged in activities necessary to ultimately carry out and implement the Redevelopment Plan for the Crossroads and the North Bay Redevelopment Project Areas [Redevelopment Project Areas], and


WHEREAS, California Community Redevelopment Law (California Health and Safety Code Sections 33000-34008) [Redevelopment Law] requires the preparation and approval of an Implementation Plan at the time of the adoption of the Redevelopment Plan, and subsequent implementation plans for each five years thereafter, which may be amended as necessary; and

WHEREAS, pursuant to Resolution R-03613, adopted by the Agency in May 6, 2003 and Resolution R-03664, adopted by the Agency July 29, 2003, the Agency approved the First Implementation Plan for the Crossroads and the Second Implementation Plan for the North Bay Redevelopment Areas; and

WHEREAS, Redevelopment Law requires the Agency to conduct a public hearing at least once within the five year term of the plan to hear testimony of all interested parties for the purpose of reviewing the Redevelopment Plan and the corresponding Implementation Plan for

2. That this activity is not a "project" and is therefore exempt from the California Environmental Quality Act [CEQA] pursuant to State of California CEQA Guidelines Section 15060(c)(3).




