A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO AN EXCLUSIVE NEGOTIATION AGREEMENT (ENA) WITH INNER-CITY INVESTMENTS, LLC FOR THE DEVELOPMENT OF LAND IN THE SAN YSIDRO REDEVELOPMENT PROJECT AREA AND RELATED ACTIONS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is

engaged in activities necessary to carry out and implement the Redevelopment Plan for

the San Ysidro Redevelopment Project [Project Area]; and

WHEREAS, the Project Area was adopted on April 16, 1996 to alleviate blighting

conditions in the San Ysidro Community; and

WHEREAS, the Agency desires to negotiate a Disposition and Development

Agreement [DDA] with Inner-City Investments, LLC for the development of parcels located

within the Project Area [Project]; and

WHEREAS, the Developer will deposit \$30,000 with the Agency to be expended

on costs related to the ENA; and

WHEREAS, the Agency Budget for the San Ysidro Project Area must be amended to reflect a \$30,000 increase in revenue; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Executive Director of the Agency, or designee, is:

- Authorized and empowered to execute an Exclusive Negotiation Agreement for a period of 180 days with Inner-City Investments, LLC for the development of land within the San Ysidro Redevelopment Project Area. A copy of the Exclusive Negotiation Agreement is on file in the office of the Secretary to the Agency as Document No. D-____04156__.
- Authorized and empowered to amend the FY 2007 Redevelopment Agency Budget for San Ysidro to accept the \$30,000 developer deposit, and authorize the appropriation and expenditure of these funds for costs related to the ENA.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(3). This determination is predicated on Section 15004 of those Guidelines, which provides direction to lead agencies on the appropriate timing for environmental review. Construction activities related to future development of the Project will require additional review under the provisions of CEQA.
