A RESOLUTION OF THE REDEVELOPMENT AGENCY OF
THE CITY OF SAN DIEGO APPROVING THE THIRD FIVE-
YEAR IMPLEMENTATION PLAN FOR THE NAVAL
TRAINING CENTER REDEVELOPMENT PROJECT.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged
in activities necessary to carry out and implement the Redevelopment Plan for the Naval
Training Center Redevelopment Project Area [the Project Area]; and

WHEREAS, California Community Redevelopment Law (California Health and Safety
Code sections 33000-34009) [California Redevelopment Law] requires the preparation and
approval of an implementation plan at the time of adoption of the Redevelopment Plan, and
subsequent implementation plans each five years thereafter, which may be amended as
necessary; and

WHEREAS, pursuant to California Redevelopment Law, the implementation plan must
describe specific goals and objectives, proposed projects, a program of actions and expenditures
proposed to be made within the five years of the implementation plan, and a description of how
the proposed projects will improve or alleviate blighting conditions in the Project Area; and


WHEREAS, by Resolution No. 2739 adopted on April 29, 1997, the Agency approved
the Naval Training Center Redevelopment Plan and First Five-Year Implementation Plan; and

WHEREAS, by Resolution No. 3492 adopted on June 25, 2002, the Agency approved the
Naval Training Center Second Five-Year Implementation Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Third Implementation Plan for the Naval Training Center Redevelopment Project is hereby approved. A copy of the Third Implementation Plan for the Naval Training Center Redevelopment Project is on file in the office of the Secretary to the Agency as Document No. D- 04181

BE IT FURTHER RESOLVED, by the Redevelopment Agency of the City of San Diego, that this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060©(3).


