A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE FISCAL YEAR 2005-2006 AUDITED FINANCIAL STATEMENTS OF THE CENTRE CITY DEVELOPMENT CORPORATION.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] and the Centre City Development Corporation [Corporation] entered into an Operating Agreement for the Corporation to provide certain staff services for the implementation of projects for redevelopment in the Centre City Redevelopment Project area; and

WHEREAS, section 2.6 of that Agreement requires the Corporation to submit to the Agency, within 120 days after the close of each fiscal year of the Corporation, a Statement of Revenues and Expenses of that fiscal year, and furnish to the Agency, detailed certified reports of an audit based on an examination in accordance with generally accepted auditing standards, prepared by an independent certified public accountant, covering the operations of the Corporation for that fiscal year and showing the revenues and expenses of that period; and

WHEREAS, the Corporation's fiscal year ended on June 30, 2006; and


WHEREAS, an annual financial audit was conducted by an independent certified public accountant, and the Corporation has submitted a copy of the Fiscal Year 2006 Audited Financial Statements; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that it accepts the Audited Financial Statements of Centre City Development Corporation for Fiscal

Year 2006; a copy of the Report on Audited Component Unit Financial Statements for the Fiscal Year Ended June 30, 2006, is on file in the office of the Secretary to the Agency as Document No. D-04195.

BE IT FURTHER RESOLVED, that this activity is not a project, and is therefore not subject to the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15060(c)(3).


