A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE DESIGN FOR THE TEN FIFTY B STREET PROJECT LOCATED IN THE CORE REDEVELOPMENT DISTRICT OF THE EXPANSION SUB AREA OF THE CENTRE CITY REDEVELOPMENT PROJECT AREA.


WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Centre City Redevelopment Project Area [Project Area]; and

WHEREAS, in order to carry out and implement the Redevelopment Plan for the Project Area, the Agency entered into an Owner Participation Agreement [OPA] with Affirmed Housing Group [Developer] which provides for the redevelopment of certain property [Site], located at 1050 B Street, San Diego, and within the Project Area, for an affordable rental housing project [Project] to contain 229 apartments (226 affordable) on the Site, such OPA is on file in the office of the Secretary to the Agency as Document No. D- 04209; and

WHEREAS, the Centre City Development Corporation, Inc. has reviewed the design of the Project and has recommended to the Agency the approval of the design of the Project to be located on the Site; NOW, THEREFORE,

BE IT RESOLVED by the Redevelopment Agency of the City of San Diego that the Agency hereby approves the design of the Project, to be located at 1050 B San Diego, which is associated with the OPA between Agency and Developer.


