A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE
CITY OF SAN DIEGO AMENDING THE ANNUAL
ADMINISTRATIVE BUDGET FOR FISCAL YEAR 2008 FOR
THE CENTRE CITY DEVELOPMENT CORPORATION.

WHEREAS the Fiscal Year 2008 annual administrative budget for the Centre City Development Corporation, Inc. [CCDC], has been prepared in accordance with Section 2.02 of the Operating Agreement between CCDC and the Redevelopment Agency of the City of San Diego [Agency]; and

WHEREAS, the administrative budget is a part of the document on file in the office of the Secretary of the Agency as Document No. D-04137, and presents a description of CCDC's work program for the coming year and the costs of existing and potential activities;

NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Fiscal Year 2008 administrative budget contained in the document on file in the Office of the Secretary to the Agency as Document No. D-04137, is hereby amended by modifying the salary range for the Human Resources Manager position from \$57,000-\$77,000 to \$71,000-\$94,000.

2. That amending of this budget constitutes authority for the expenditure of available funds in Fiscal Year 2008, provided that funds are available from the tax increment generated by the projects; from bond sales, land sales and developer proceeds.


3. That the City Auditor and Comptroller is hereby authorized to (a) establish the necessary accounts, (b) appropriate all monies available in each project fund up to the amounts budgeted herein, (c) record the expenditures of funds and the recovery of all accrued costs subject to the amount of revenues available in each project fund, and (d) provide advances to CCDC for operating expenses up to an amount equal to 15 (fifteen) percent of the approved annual CCDC administrative budget.

4. That CCDC's President, or designee, is hereby authorized to request the City Auditor and Comptroller to make budgetary transfers between the line items in accordance with Section 1.07 of the Operating Agreement between the Agency and CCDC which is on file in the Office of the Secretary of the Agency as Document No. 862.

5. That the activities set forth herein are not a "project" and are therefore exempt from the California Environmental Quality Act ["CEQA"] pursuant to State CEQA Guidelines Section 15060(c)(3).


