A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION TO ADVERTISE, RECEIVE, AWARD, EXECUTE AND ADMINISTER A CONTRACT WITH THE LOWEST RESPONSIBLE BIDDER FOR THE CONSTRUCTION OF CORTEZ HILL STREETSCAPE REHABILITATION PROJECT

WHEREAS, the Redevelopment Agency of the City of San Diego ["Agency"] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Cortez Redevelopment District of the Expansion Sub Area of the Centre City Redevelopment Project a ["Project Area"]; and

WHEREAS, the Centre City Development Corporation ["Corporation"] is responsible for implementing redevelopment projects in the Project Area; and

WHEREAS, in order to carry out and implement the Redevelopment Plan, the Agency approved the Implementation Plans for the period of July 2004 - June 2009 for the Centre City and Horton Plaza Redevelopment Projects; and

WHEREAS, the Implementation Plan identifies the need to improve and enhance public right-of-way, providing new paving, landscape, sidewalk, public art and street furniture; and

WHEREAS, the Agency has duly considered all conditions of the proposed payment for the improvements and believes that the payment by the Agency of all or part of the cost of the improvements is in the best interest of the City and of the health, safety, morals, and welfare of its residents, and in accord with the public purpose and provisions of applicable state and local law requirements: NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

- 1. That the Corporation, on behalf of the Agency, is authorized to advertise and receive bids for the construction of the Cortez Hill Streetscape Rehabilitation Project ["Project"];
- 2. That the Agency authorizes the Executive Director and/or his designee to award a contract in an amount not to exceed \$785,000 to the lowest responsible bidder, provided bids are within the established budget and all other requirements are met, including approval of the contract by the Agency's General Counsel;
- 3. That the Agency authorizes the Corporation, on behalf of the Agency, to administer said contract.
- 4. That the Agency finds and determines that the construction of the Project for which the Agency proposes to pay is of benefit to the Project Area; that the Agency finds and determines that no other reasonable means for financing the Project is available to the community and that the Project will assist in eliminating one or more blighting conditions inside the Project Area, and that the Project is consistent with the Centre City and Horton Plaza Implementation Plans for July 2004-2009, on file in the office of the Secretary to the Agency pursuant to California Health and Safety Code Section 33490, all as described in Attachment B.
- 5. That the Agency does hereby find and determine that the Project is categorically exempt from environmental review under the California Environmental Quality Act (CEQA)

pursuant to CEQA Guidelines section 15302, Replacement or Reconstruction of existing structures and facilities. APPROVED: MICHAEL J.
