A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AMENDING THE ANNUAL REDEVELOPMENT AGENCY BUDGET PREVIOUSLY ADOPTED FOR FISCAL YEAR 2008, INCREASING THE BUDGET FOR THE NORTH PARK REDEVELOPMNET PROJECT AREA TO INCLUDE SURPLUS OF \$1,100,000 IN TAX INCREMENT REVENUE AND TO AUTHORIZE EXPENDITURE FOR THE NORTH PARK REDEVELOPMENT PROJECT AREA.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the North Park Redevelopment Project area of the City of San Diego [City]; and

WHEREAS, the Agency approved the Fiscal Year 2008 Redevelopment Agency Budget on May 15, 2007, a copy of which is on file in the office of the secretary to the Agency as Document No.: 04137; and

WHEREAS, the revised tax increment revenue projection for the North Park Redevelopment Project Area is \$1,100,000 higher than the Fiscal Year 2008 budgeted projection; and

WHEREAS, the Agency now desires that a partial repayment of North Park

Redevelopment Project area debt be made to the City for the previously loaned funds to reduce
the outstanding principal amount of said loan owed to the City by the North Park Redevelopment

Project area; and

WHEREAS, funds are available in the North Park Redevelopment Project Area for the purpose of accomplishing such partial repayment; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego:

1. That the Executive Director or designee is authorized and directed to amend the North Park Redevelopment Project 2008 Budget by increasing it to include the anticipated surplus of \$1,100,000 in tax increment revenue and directs that said revenue is authorized to be expended for the North Park Redevelopment Project Area as follows:

Fund 98300 – North Park Project Area (Capital Fund): \$308,000

Fund 98307 – North Park, City Loan Repayment: \$352,500

Fund 98302 – North Park, Low & Moderate Income Housing: \$220,000

Fund 98303 – North Park, Taxing Agencies Allocation: \$220,000

- 2. That approval of this amendment constitutes authority for the expenditure of funds from Fund 98307 for the partial repayment of principal to the City for previously loaned funds by the City to the Agency in the amount of \$352,500.
 - 3. That the City Auditor/Comptroller is hereby authorized:
 - a. To establish the necessary accounts.
- b. To appropriate and to allot the money available in the project funds and/or appropriate debt service funds as a result of the adoption of this resolution in accordance with the direction given herein.
- 4. That the Executive Director, or designee, is hereby authorized and directed to expend funds from the North Park Redevelopment Project for the partial repayment of principal to the City for previously loaned funds by the City to the Agency.
