A RESOULTUION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AMENDING THE PROGRAM BUDGET FOR FISCAL YEAR 2008 FOR THE REDEVELOPMENT PROJECTS ADMINISTERED BY THE REDEVELOPMENT DIVISION OF THE CITY'S CITY PLANNING & COMMUNITY INVESTMENT DEPARTMENT TO TRANSFER APPROPRIATAIONS AND AUTHORIZE EXPENDITURES OF \$435,000 OF TAX INCREMENT PROCEEDS FOR THE REPAYMENT OF GENERAL FUND LOANS TO THE CITY OF SAN DIEGO.

WHEREAS, the Redevelopment Division of the City's City Planning & Community

Investment Department is engaged in activities necessary to carry out and implement
redevelopment plans in the Naval Training Center [NTC] and San Ysidro Redevelopment Project

Areas on behalf of the Redevelopment Agency of the City of San Diego [Agency] for the City of
San Diego [City]; and

WHEREAS, the Agency previously received General Fund monies as a loan from the City and now proposes to repay \$375,000 generated from the NTC Redevelopment Project Area and \$60,000 generated from the San Ysidro Redevelopment Project Area; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Agency authorizes a General Fund loan repayment to the City of San Diego in the amount of \$375,000 from the NTC Redevelopment Project Area and \$60,000 from the San Ysidro Redevelopment Project Area.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore exempt from CEQA pursuant to State CEQA Guidelines Section 15060(c)(3).
