A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, CALIFORNIA, AUTHORIZING THE FY 09 PAYMENT OF A PORTION OF THE HUD SECTION 108 LOAN #B-96-MC-06-0542-A TO THE CITY OF SAN DIEGO (CITY) IN THE AMOUNT OF \$450,000 FROM CENTRAL IMPERIAL REDEVELOPMENT AREA'S FY 2007 TAX ALLOCATION BONDS; AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF FUNDS; AND AMENDING THE FY08 SEDC PROGRAM BUDGET IN CENTRAL IMPERIAL REDEVELOPMENT PROJECT AREA TO INCLUDE THE REPAYMENT OF THE LOAN TO THE CITY ON BEHALF OF COUNCIL DISTRICT FOUR.

WHEREAS, on September 14, 1992, the Council of the City of San Diego, California [City Council] adopted Ordinance No. O-17831 (NEW SERIES), which is on file in the office of the City Clerk as Document No. O-17831 approving and adopting a Redevelopment Plan for the Central Imperial Redevelopment Project Area; and

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out in the City of San Diego the functions and requirements of the CRL and to implement redevelopment plans for the City of San Diego [City]; and

WHEREAS, on May 6, 1996, resolution number R-287278 was adopted by the City authorizing submission of the an application for a Section 108 Loan Guarantee (B-96-MC-06-0542-A) to the United States Department of Housing and Urban Development (HUD); and

WHEREAS, the aforementioned resolution also authorized the source of funds for the repayment of the Section 108 loan to be repaid from the Fourth District's Community Development Block Grant allocations.

WHEREAS, the application to HUD and the Cooperation and Pledge Agreement between the Redevelopment and the Cit of San Diego authorized the use of SEDC Tax Increment Revenues and/or land sales for the repayment of the Section 108 loan payments; and WHEREAS, on May 15, 2007, the Agency approved SEDC's FY08 Program budget which included the taxable FY 07 Tax Allocation Bond proceeds in the Central Imperial Redevelopment Project Area; and

WHEREAS, on June 12, 2007, and reaffirmed on July 10, 2007, the City authorized issuance of the FY 2007 tax allocation bonds which included \$450,000 (net of the cost of issuance) of taxable bond proceeds for the payment of a portion of the HUD Section 108 Loan #B-96-MC-06-0542-A on behalf of the Council District Four; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of City of San Diego as follows:

1. Authorize the FY 09 payment of a portion of the HUD Section 108 Loan #B-96-MC-06-0542-A to the City in the amount of \$450,000 from Central Imperial Redevelopment Area's FY 2007 tax allocation bonds.

Authorize the appropriation and expenditure of funds and decrease Fund No.
98775 budget and increase the debt service (Fund No. 98782) by \$450,000 in the Central
Imperial Redevelopment Project Area for the FY 09 payment of the loan to the City on behalf of
Council District Four.

3. That this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEAQ] pursuant to CEQA Guidelines Section 15060(c)(3).
