A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO TO APPROVE BID NO. KO84022CA AND FINAL PROJECT SPECIFICATIONS/PLANS NO. 4022A FOR THE PARK BOULEVARD AT HARBOR DRIVE PEDESTRIAN BRIDGE PROJECT; AUTHORIZE THE EXECUTIVE DIRECTOR OF THE AGENCY TO ACCEPT THE BASE BID AND FIVE DEDUCTIVE ALTERNATES AND AWARD THE CONSTRUCTION CONTRACT TO REYES CONSTRUCTION, INC., IN THE AMOUNT OF \$21,672,531; AND AUTHORIZE THE CORPORATION TO ADMINISTER SAID CONSTRUCTION CONTRACT.

WHEREAS, the Redevelopment Agency of the City of San Diego [the "Agency"] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the East Village Redevelopment District of the Expansion Sub Area of the Centre City Redevelopment Project [the "Project Area"]; and

WHEREAS, the Centre City Development Corporation [the "Corporation"], on behalf of the Agency, is responsible for implementing redevelopment projects in the Project Area; and

WHEREAS, the Agency desires to proceed with construction of the Park Boulevard at Harbor Drive Pedestrian Bridge Project [the "Project"], which will consist of an approximately 550' long, 16' wide, pedestrian bridge spanning railroad right of way, and City of San Diego right-of-way at Park Boulevard and Harbor Drive in the East Village Redevelopment District that will provide a safe pedestrian passing; and

WHEREAS, in order to implement construction of the Project, the Corporation has reviewed and recommends that the Agency consent to and authorize the Corporation to award a

construction contract of the on-site and off-site improvements for the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

- That the Agency authorizes the Executive Director to accept the base bid and five deductive alternates and award the construction contract to Reyes Construction, Inc. in the amount of \$21,672,531;
- 3. That the Agency authorizes the Corporation to administer said construction contract.
