A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO MAKING CERTAIN FINDINGS WITH RESPECT TO FUNDING THE CONSTRUCTION OF THE STREETSCAPE IMPROVEMENTS ALONG IMPERIAL AVENUE FROM 45TH STREET TO EUCLID AVENUE WITHIN THE CENTRAL IMPERIAL REDEVELOPMENT PROJECT AREA, AUTHORIZING THE SOUTHEASTERN ECONOMIC DEVELOPMENT CORPORATION ON BEHALF OF THE REDEVELOPMENT AGENCY, TO ADVERTISE AND RECEIVE BIDS, SELECT CONTRACTOR, AND APPROVING THE EXPENDITURE OF FUNDS FOR THE CONSTRUCTION OF THE IMPROVEMENTS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Central Imperial Redevelopment Project Area [Project Area]; and

WHEREAS, the Agency funds projects to improve economic and physical conditions in designated areas of the City of San Diego; and

WHEREAS, in furtherance of the objectives of the Project Area the Agency wishes to install streetscape improvements along Imperial Avenue from 45th Street to Euclid Avenue [Project] in the total amount of up to \$435,000; and

WHEREAS, the Agency has determined that the funding of the Project is in accord with the public purpose and provisions of applicable state and local law and requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

- 1. That the Agency hereby finds and determines that the construction of streetscape improvements within the Central Imperial Redevelopment Project Area, for which the Agency proposes to fund, is consistent with the Implementation Plan adopted pursuant to Community Redevelopment Law, Section 33490; is of benefit to the Central Imperial Redevelopment Project Area; that no other reasonable means of financing the Project is available to the community; and that the payment of funds for the Project will assist in the elimination of one or more blighting conditions inside the Project Area as more fully described in the Findings, Attachment No. 2.
- 2. That the Southeastern Economic Development Corporation [SEDC], on behalf of the Agency, is hereby authorized, to advertise and receive bids for the construction of the streetscape improvements along Imperial Avenue form 45th Street to Euclid Avenue within the Central Imperial Redevelopment Project Area.
- 3. That SEDC, on behalf of the Agency, is hereby authorized to award and administer the contracts to the lowest responsible bidders, provided that the bids are within the established budget, an amount which shall not exceed \$435,000, and the other requirements in the bid documents are met.
- 4. That the Executive Director of the Agency, or his designee, is herby authorized to spend up to \$435,000 for construction of the Project, and that there shall be authorized a decrease in the appropriation in Fund No. 98775 by \$435,000, and a corresponding increase in the appropriation in Fund No. 98793 by \$435,000.
- 5. That this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA], pursuant to CEQA Guidelines section 15301(c) and section 15304.
