A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE ACCEPTANCE AND EXPENDITURE OF \$95,738 FROM THE CITY HEIGHTS REDEVELOPMENT PROJECT AREA AND THE TRANSFER OF THE FUNDS TO CAPITAL IMPROVEMENT PROGRAM BUDGET NO. 52-293.0

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in the activities necessary to carry out and implement the Redevelopment Plan for the City Heights Redevelopment Project Area [Project Area]; and

WHEREAS, the Agency has been requested to accept funds to be used to pay the cost of the installation of streetlights located within ten blocks of the Urban Village, since the City of San Diego Capital Improvement Program Budget presently has insufficient funding for the installation of such streetlights; and

WHEREAS, the Project Area community members would benefit from the installation of streetlights; and

WHEREAS such activity would further the Agency objectives in the Redevelopment Plan for the Project Area; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Agency amends the Fiscal Year 2008 budget to accept the funds in the amount of \$95,738 for the purchase and installation of streetlights in the Project Area.

2. That the Redevelopment Agency authorizes the transfer of the same \$95,738 to the City for the purchase and installation of streetlights in the City Heights Redevelopment Project Area.

BE IT FURTHER RESOLVED, that this activity is exempt from CEQA pursuant to State of California CEQA Guidelines Section 15301(c).
