leased to Lessee certain real property [Leased Premises] located within the Linda Vista

Redevelopment Project Area for the operation and maintenance of a roller skating and retail

complex; and

WHEREAS, on November 30, 2005, the Agency and Lessee entered into a First

Amendment to the Lease which extended the term of the Lease through December 31, 2006; and

WHEREAS, on July 11, 2007, the Agency and Lessee entered into a Second Amendment

to the Lease which extended the term of the Lease through June 30, 2008; and

WHEREAS, the Parties desire, by this Third Amendment to the Lease, to extend the term of the Lease for an additional six (6) months effective as of July 1, 2008, for the continued operation and maintenance of a roller skating and retail complex on the Leased Premises; and

WHEREAS, the Executive Director of the Agency, or designee, has recommended that the Agency approve this Third Amendment to the Lease; NOW, THEREFORE,

skating and retail complex on the Leased Premises.
