A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION TO EXECUTE A SECOND AMENDMENT TO THE AGREEMENT WITH NASLAND ENGINEERING FOR ON-CALL ENGINEERING SERVICES FOR MULTIPLE EXISTING AND FUTURE PUBLIC WORKS PROJECTS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Centre City Redevelopment Project [Project Area]; and

WHEREAS, the Centre City Development Corporation [CCDC] is responsible for implementing redevelopment within the Project Area; and

WHEREAS, CCDC and Nasland Engineering entered into an Agreement for on-call engineering services dated April 5, 2005, in an amount not to exceed \$250,000 [Agreement]; and

WHEREAS, On September 27, 2006, a First Amendment to the Agreement was approved by the CCDC Board, in an amount not to exceed \$200,000; and

WHEREAS, CCDC proposes the Agency further amend the Agreement, through a Second Amendment to the Agreement, by adding an amount not to exceed \$300,000 for on-call engineering services; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Executive Director, or his designee, is authorized to enter into the Second Amendment to the Agreement with Nasland Engineering for on-call engineering services in an amount not to exceed \$300,000. The total compensation under the Agreement will not exceed \$750,000.

2. That the Auditor and Comptroller are authorized to appropriate and expend up to \$300,000 from the funds listed on Auditor's Certificate <u>2800899</u> for the purpose of financing the Second Amendment to the Agreement.

3. That this activity is not a "project" and is therefore exempt form the California Environmental quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060(c)(3).
