A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE EXPENDITURE UP TO \$2,000,000 FROM THE SAN YSIDRO REDEVELOPMENT PROJECT AREA AND AUTHORIZE THE TRANSFER OF THE FUNDS TO FUND NUMBER 10269, SAN YSIDRO REDEVELOPMENT PLANNING CONTRIBUTION FOR THE SAN YSIDRO COMMUNITY PLAN UPDATE PROCESS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in the activities necessary to carry out and implement the Redevelopment Plan for the San Ysidro Redevelopment Project Area [Project Area]; and

WHEREAS, the goal of the Redevelopment Plan for the Project Area is to improve, promote, and preserve the positive neighborhood characteristics in San Ysidro, while correcting physical and economic deficiencies in the community; and

WHEREAS, the Agency has been requested to fund the cost of the San Ysidro Plan Update; and

WHEREAS, the Community Plan Update would benefit the Project Area by improving traffic circulation, provide an economic stimulus within the area and promote viable land use strategies; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Agency finds and determines that the San Ysidro Community Plan Update is of benefit to the Project Area; that such action will assist in eliminating of one or more blighting

conditions inside the Project Area; and that such an action is consistent with the Third Implementation Plan filed for the Project Area by the Agency on October 10, 2006, and listed as Document No. 04073 in the office of the Secretary to the Agency pursuant to California Health and Safety Code Section 33490.

2. That the Redevelopment Agency approves the transfer of funds from the San Ysidro Redevelopment Project Area to Fund No. 10269, San Ysidro Redevelopment Planning Contribution not to exceed \$2,000,000 for implementation of the Community Plan Update.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to the California Environmental Quality Act [CEQA] pursuant to State CEQA Guidelines Section 15060 (c) (3).
