WHEREAS, in connection with the Third Implementation Agreement to the DDA, the Developer has now submitted to the Agency revised basic concept and schematic drawings pertaining to the Project; and

WHEREAS, the development and implementation of the Project, as amended by the Third Implementation Agreement to the DDA, is in the best interests of the City of San Diego and the health, safety, morals, and welfare of its residents, and in accord with the public purposes and provisions of applicable state and local law and requirements; NOW, THEREFORE,
