A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO RECEIVING AND FILING THE FISCAL YEARS 2007-2008 AND 2008-2009 AUDITED FINANCIAL STATEMENTS OF THE SOUTHEASTERN ECONOMIC DEVELOPMENT CORPORATION, INC.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] and the Southeastern Economic Development Corporation, Inc. [Corporation] entered into an Operating Agreement effective February 25, 1981 [Operating Agreement], for the purpose of the Corporation providing certain staff services for the implementation of projects for redevelopment within the Southcrest, Mount Hope, Central Imperial, and Gateway Center West Redevelopment Project Areas [Project Areas] and the Dells Imperial Study Area [collectively referred to herein as the SEDC Area of Influence]; a copy of the Operating Agreement is on file in the office of the Secretary to the Agency as Document No. 782; and

WHEREAS, Section 2.6 (b) of the Operating Agreement requires the Corporation to submit to the Agency, within 120 days after the close of each fiscal year of the Corporation, a Statement of Revenues and Expenses of that fiscal year and to furnish to the Agency detailed certified reports of an audit based on an examination in accordance with generally accepted auditing standards, prepared by an independent certified public accountant, covering the operations of the Corporation for that fiscal year and showing the revenues and expenses for such period; and

WHEREAS, the Corporation's fiscal year for 2008 ended on June 30, 2008 and for 2009

ended on June 30, 2009; and

WHEREAS, the annual financial audits were conducted by separate independent certified

public accountants for the Fiscal Years 2007-2008 and 2008-2009 respectively, and the

Corporation has submitted to the Agency copies of the Fiscal Years 2007-2008 and 2008-2009

Audited Financial Statements, which each incorporate the Independent Auditor's Report; NOW,

THEREFORE.

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego [Agency],

that the Agency hereby receives and files the Fiscal Years 2007-2008 and 2008-2009 Audited

Financial Statements of the Southeastern Economic Development Corporation, Inc.; copies of

the Fiscal Years 2007-2008 and 2008-2009 Audited Financial Statements shall be placed on file

in the office of the Secretary of the Agency as Document No. D=0.451.4  $\alpha$  and Document

No. D-04514b respectively.
