A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION, INC.
[CORPORATION] TO ENTER INTO AN AGREEMENT WITH KEYSER MARSTON ASSOCIATES, INC. [KMA] FOR ASNEEDED ECONOMIC, FINANCIAL AND MARKET ANALYSIS CONSULTING SERVICES AND AUTHORIZING AN EXPENDITURE OF AN AMOUNT NOT TO EXCEED \$250,000 ALLOCATED IN THE FISCAL YEAR 2009-2010 BUDGETS FOR THE CENTRE CITY AND HORTON PLAZA REDEVELOPMENT PROJECT AREAS TO BE USED TOWARD THE CONSULTING SERVICES PURSUANT TO AN AGREEMENT BETWEEN CORPORATION AND KMA.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plans for the Centre City and Horton Plaza Redevelopment Project Areas [Project Areas]; and

WHEREAS, the Centre City Development Corporation, Inc. [Corporation] is a non-profit corporation authorized to administer, on behalf of the Agency, the Project Areas; and

WHEREAS, the Corporation issued a Request for Qualifications [RFQ] for economic, financial and market analysis consultant services to be provided on an as-needed basis to the Corporation on behalf of the Agency; and

WHEREAS, after evaluating all statements of qualifications received in response to the RFQ, the evaluation committee selected Keyser Marston Associates, Inc. [KMA] as the primary consultant firm from which to draw for economic, financial and market analysis professional services on an as-needed basis; and

WHEREAS, pursuant to Section 2.10(a) of the Operating Agreement entered into by and between the Agency and Corporation, subject to compliance with the purchasing and contracting policies and procedures of the Corporation, the Corporation has the authority to enter into agreements and contracts in the usual and ordinary course of business without the prior approval of the Agency provided that such action is budgeted for and contemplated in the Agency approved budget and a certification of funds is issued by the City Comptroller; and

WHEREAS, the Corporation desires that the Agency authorize the Corporation to enter into an agreement with KMA for as-needed economic, financial and market analysis consultant services with a total compensation payable to KMA pursuant to such agreement in an amount not to exceed \$250,000 and authorize the expenditure of an amount not to exceed \$250,000 allocated in the Fiscal Year 2009-2010 Budgets for the Centre City and Horton Plaza Redevelopment Project Areas to be used toward said consultant services pursuant to an agreement between the Corporation and KMA; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego [Agency] as follows:

1. That the Agency authorizes the Centre City Development Corporation, Inc. [Corporation] to enter into an agreement with Keyser Marston Associates, Inc. [KMA] for asneeded economic, financial and market analysis consultant services in accordance with the Scope of Services and the Professional Services Agreement attached to Report No. CCDC-10-18 as Attachments A and B respectively, with a total compensation payable to KMA pursuant to such agreement in an amount not to exceed \$250,000.

- 2. That no funds authorized by this Resolution shall be expended by the Corporation for the services of KMA in connection with a potential increase in the tax increment cap set forth in the Centre City Redevelopment Plan.
- 3. That the Agency authorizes the Chief Financial Officer, as delegated, to appropriate, encumber and expend funds of up to \$250,000 allocated in the Fiscal Year 2009-2010 Budgets for the Centre City and Horton Plaza Redevelopment Project Areas to be used toward as-needed economic, financial and market analysis consultant services provided by KMA pursuant to an agreement between the Corporation and KMA.
