A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE TRANSMITTAL OF THE REPORT TO COUNCIL AND CONSENTING TO THE JOINT PUBLIC HEARING FOR CONSIDERATION OF THE PROPOSED AMENDMENTS TO MERGE THE CENTRAL IMPERIAL, GATEWAY CENTER WEST, MOUNT HOPE, AND SOUTHCREST REDEVELOPMENT PROJECT AREAS INTO THE SOUTHEASTERN SAN DIEGO MERGED PROJECT AREA AND OTHER AMENDMENTS TO THE REDEVELOPMENT PLANS FOR THE SOUTHEASTERN SAN DIEGO PROJECT AREAS UPON ADOPTION OF THE MERGER.

WHEREAS, the Redevelopment Agency of the City of San Diego (Agency) is authorized to exercise its powers, all under and pursuant to the Community Redevelopment Law of the State of California, being Part 1 of Division 24 (commencing with Section 33000) of the California Health and Safety Code, as amended, (Law); and

WHEREAS, the Agency is engaged in activities necessary to carry out and implement the Redevelopment Plans for the Central Imperial, Gateway Center West, Mount Hope, and Southcrest Redevelopment Project Areas (Project Areas) in accordance with the Law; and

WHEREAS, the Agency is proposing to adopt the following amendments to the Redevelopment Plans for the Project Areas (Amendments):

(i) Merge the Central Imperial, Gateway Center West, Mount Hope, and Southcrest Redevelopment Project Areas into one project area to be called the Southeastern San Diego Merged Redevelopment Project Area (Merged Project Area);

(ii) Eliminate the tax increment limit for Central Imperial Amendment 2 and Amendment 3 Component Areas, and create a combined tax increment limit and bonded indebtedness limit for the Merged Project Area;

(iii) Extend the duration of the Redevelopment Plan for the Gateway Center West Component Area of the Merged Project Area and the time limit for the repayment of debt by ten years;

(iv) Eliminate the time limit for the incurrence of debt for the Gateway Center West and Central Imperial Component Areas of the Merged Project Area; and

(v) Change the land use provisions in the Redevelopment Plans for each Component Area of the Merged Project Area to incorporate by reference the most recently adopted General Plan, Community Plans, and any Specific Plans, as they may be amended from time to time; and

WHEREAS, the Southeastern Economic Development Corporation, Inc. (SEDC), on behalf of the Agency, has prepared a Report to Council for the proposed Amendments in accordance with Section 33352 of the Law; and

WHEREAS, the Agency desires to transmit the Report to Council to the Council of the City of San Diego for consideration of the proposed Amendments; and

WHEREAS, in accordance with Section 33458 of the Law, a joint public hearing may be held with the consent of the City Council and the Agency to consider the proposed Amendments; and

WHEREAS, the joint public hearing must be held no earlier than thirty (30) days after the required notices of the joint public hearing are published and mailed in accordance with Section 33452 of the Law; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred in accordance with the Law; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Agency consents to the joint public hearing, which shall be held no earlier than thirty (30) days after the required notices are published and mailed in accordance with Section 33452 of the Community Redevelopment Law.

2. That the Agency authorizes the transmittal of the Report to Council to the City Council for consideration of the proposed Amendments at the joint public hearing.


3. That the Agency authorizes and directs the Agency Executive Director or designee to implement the necessary transmittals of the Report to Council; a copy of the Report to Council shall be placed on file in the Office of the Agency Secretary as Document

No. D- 04593.

4. That the Agency authorizes the Agency Executive Director or designee to execute all documents on behalf of the Agency that are necessary and appropriate to carry out and implement the purposes set forth in this Resolution according to its terms, and to administer the Agency's obligations, responsibilities and duties to be performed hereunder.


