

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR AN ENVIRONMENTAL JUSTICE TRANSPORTATION PLANNING GRANT IN THE AMOUNT OF \$250,000 FOR THE SR-94 EUCLID TO MARKET/IMPERIAL CORRIDOR PLAN.

WHEREAS, the California Department of Transportation (Caltrans) has established the California Transportation Planning Grant Program (Grant Program), which includes Community-Based and Environmental Justice grants to provide state funding for transportation-related planning activities to engage the community in efforts to improve mobility, access, and economic vitality; and

WHEREAS, the Southeastern Economic Development Corporation, Inc. (SEDC) has prepared an application that will request funding of \$250,000 under the Grant Program toward a local transportation study known as the SR-94 Euclid to Market/Imperial Corridor Study (Transportation Corridor Study); and

WHEREAS, the Transportation Corridor Study will evaluate the need for "Complete Street" design and installation of missing infrastructure along Euclid Avenue from State Route 94 to the intersections of Market and Imperial in Southeastern San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego as follows:

1. SEDC's President, or designee, acting on behalf of the Agency, is authorized to submit an application to Caltrans seeking to secure funding under the Grant Program for an amount up to \$250,000 toward the Transportation Corridor Study.

2. SEDC's President, or designee, acting on behalf of the Agency, is authorized to take all actions, conduct all negotiations and execute and submit all documents, including but not limited to applications, agreements and amendments, which may be necessary or appropriate to secure the desired funding toward the Transportation Corridor Study under the Grant Program.

3. The Chief Financial Officer is authorized to accept up to \$250,000 if the grant funding is secured toward the Transportation Corridor Study under the Grant Program.

4. The Chief Financial Officer is authorized to establish a special interest-bearing account, if required.

The Chief Financial Officer is authorized to appropriate and expend up to
\$250,000 for the purpose of the Transportation Corridor Study, contingent upon receipt of a fully
executed grant agreement.
