A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO RECEIVING AND FILING THE FISCAL YEAR 2009-2010 AUDITED FINANCIAL STATEMENTS OF THE SOUTHEASTERN ECONOMIC DEVELOPMENT CORPORATION

WHEREAS, the Redevelopment Agency of the City of San Diego (Agency) and the Southeastern Economic Development Corporation (Corporation) entered into an Operating Agreement effective February 25, 1981 (Operating Agreement), for the purpose of the Corporation providing certain staff services for the implementation of projects for redevelopment within the Southcrest, Mount Hope, Central Imperial, and Gateway Center West Redevelopment Project Areas (Project Areas) and the Dells Imperial Study Area; a copy of the Operating Agreement is on file in the office of the Secretary to the Agency as Document No. 782; and

WHEREAS, the Agency and the Corporation entered into an Amended and Restated Operating Agreement dated June 9, 2010 (Amended Operating Agreement), which is on file in the office of the Secretary to the Agency as Document No. D-04499; and

WHEREAS, Section 2.17 (b) of the Amended Operating Agreement requires the Corporation to submit to the Agency within 135 days after the close of each fiscal year of the Corporation, the audited financial statements, including an opinion prepared by an independent certified public accountant, covering the business operations of the Corporation for that fiscal year; and

WHEREAS, the Corporation's Fiscal Year for 2010 ended on June 30, 2010; and

WHEREAS, the annual financial audits were conducted by independent certified public accountants for the Fiscal Year 2010, and the Corporation has submitted to the Agency copies of the Fiscal Year 2010 Audited Financial Statements, which incorporates the Independent Auditor's Report; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, that the Fiscal Year 2010 Audited Financial Statements of the Southeastern Economic Development Corporation are hereby received and filed; copies of the Fiscal Year 2010 Audited Financial Statements shall be placed on file in the office of the Secretary of the Agency as Document No. 1) 204650.
