A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO REGARDING THE PUBLIC HEARING TO REVIEW THE REDEVELOPMENT PLAN AND CORRESPONDING IMPLEMENTATION PLAN FOR THE CROSSROADS REDEVELOPMENT PROJECT AREA AND EVALUATE THE PROGRESS OF THE REDEVELOPMENT PROJECT AND ACCEPTING THE MID-TERM REVIEW IN CONNECTION THEREWITH.

WHEREAS, the Redevelopment Agency of the City of San Diego (Agency) is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Crossroads Redevelopment Project Area (Project Area), and

WHEREAS, California Community Redevelopment Law (California Health and Safety Code Sections 33000-34008) (Redevelopment Law) requires the preparation and approval of an implementation plan at the time of the adoption of the redevelopment plan for a redevelopment project, and subsequent implementation plans for each five years thereafter, which may be amended as necessary; and

WHEREAS, pursuant to Resolution No. 3613, adopted on May 3, 2003, the Agency approved the implementation plan together with the redevelopment plan (Redevelopment Plan) for the Project Area at the time the Project Area was established; and

WHEREAS, pursuant to Resolution No. R-04266, adopted on May 19, 2008, the Agency adopted the second five-year implementation plan (Implementation Plan) for the Project Area; a

copy of said document is on file in the office of the secretary of the Agency as Document No. D-04266; and

WHEREAS, Redevelopment Law further requires redevelopment agencies, at least once within the five year term of the implementation plan, to conduct a public hearing and hear testimony of all interested parties for the purpose of reviewing the redevelopment plan and corresponding implementation plan for each redevelopment project and evaluating the progress of the redevelopment project within the jurisdiction of the agency; and

WHEREAS, Agency staff has prepared the Mid-Term Review of the Redevelopment Plan and corresponding Implementation Plan for the Project Area which reviews the programs, projects and goals described in the Redevelopment Plan and corresponding Implementation Plan and evaluates the progress of the Project Area; and

WHEREAS, on March 15, 2011, the Agency conducted a public hearing on the Mid-Term Review; after receiving public testimony (both written and oral), the Agency requested staff to address the comments received during the public hearing and to return the Mid-Term Review for Agency consideration to a subsequent noticed public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego, as follows:

1. That the Agency has duly conducted a public hearing and has heard testimony of all interested parties for the purpose of reviewing the Redevelopment Plan and corresponding Implementation Plan for the Crossroads Redevelopment Project Area and evaluating the progress of the Crossroads Redevelopment Project.

2. That the Agency accepts the Mid-Term Review of the Redevelopment Plan and corresponding Implementation Plan for the Crossroads Redevelopment Project Area as

presented, a copy of the Mid-Term Review shall be placed on file in the office of the secretary of the Agency as Document No. D- 04651.


