A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO THE AGREEMENT WITH KEYSER MARSTON ASSOCIATES, INC. FOR ECONOMIC CONSULTANT SERVICES.

WHEREAS, the Redevelopment Agency of the City of San Diego (Agency) is engaged in activities necessary to carry out and implement the Redevelopment Plans for the various redevelopment projects in the City of San Diego (City); and

WHEREAS, in October 2009, the Agency issues a Request for Qualifications (RFQ) for economic consultants to provide real estate market, economic and financial and redevelopment professional services to the Redevelopment Division and the Southeastern Economic Development Corporation, Inc. on an as-needed basis; and

WHEREAS, after evaluating all statements of qualifications received in response to the RFQ, the evaluation committee selected Keyser Marston Associates, Inc. (KMA) as one of the consultant firms from which to draw on a project-by-project basis; and

WHEREAS, the Agency entered into an as-needed agreement with KMA to provide economic consultant services (Agreement), which Agreement was filed with the Agency on February 16, 2010, as Document No. D-04481; and

WHEREAS, the Agency desires to increase the compensation by \$289,000 for a total compensation not to exceed \$589,000; NOW, THEREFORE,

(RA-2011-64) (COR.COPY)

BE IT RESOLVED, by the Redevelopment Agency of the City of San Diego as follows:

- 1. That the First Amendment to the Agreement is approved.
- 2. That the total compensation under the First Amendment to the Agreement is increased by \$289,000 for a total compensation not to exceed \$589,000 and that the City Chief Financial Officer, as delegated, is authorized to appropriate, encumber and expend Agency funds of up to \$135,000 immediately and the remaining \$154,000 shall be contingent on first furnishing a certificate that funds are, or will be, on deposit in the City Treasury for additional work that may be required on an as-needed basis.
- 3. That the Executive Director of the Agency, or designee, is authorized and empowered to execute the First Amendment to the Agreement, for and on behalf of the Agency, and to administer the Agency's obligations, responsibilities, and duties to be performed under the Agreement.
