A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE REHABILITATION LOAN AGREEMENT WITH WANG'S NORTH PARK PARTNERS, LP FOR THE REHABILITATION OF PROPERTY AT 3029 UNIVERSITY AVENUE IN THE NORTH PARK REDEVELOPMENT PROJECT AREA, APPROVING THE EXPENDITURE OF \$500,000 FROM NONHOUSING TAX INCREMENT FUNDS FOR THE REHABILITATION PROJECT, AND AUTHORIZING THE EXECUTIVE DIRECTOR OR DESIGNEE TO EXECUTE THE REHABILITATION LOAN AGREEMENT.

WHEREAS, the Redevelopment Agency of the City of San Diego (Agency) is engaged in activities necessary to carry out and implement the Redevelopment Plan for the North Park Redevelopment Project Area (Project Area); and

WHEREAS, in order to carry out and implement the Redevelopment Plan in the Project Area, the Agency has negotiated and proposes to enter into a Rehabilitation Loan Agreement (Agreement) with Wang's North Park Partners, LP, a California limited partnership (Borrower), pursuant to which the Agency will provide financial assistance to Borrower in the form of a forgivable loan in an amount not to exceed Five Hundred Thousand Dollars (\$500,000) (Loan) for the rehabilitation of certain real property located at 3029 University Avenue in San Diego (Project), as further described in the Agreement; and

WHEREAS, the source of the Loan is the Agency's non-housing tax increment funds derived from the Project Area; and

WHEREAS, Borrower has executed and submitted to the Agency copies of the proposed Agreement in a form acceptable to Borrower and Agency staff; and

WHEREAS, the Agency has duly considered all of the terms and conditions in the proposed Agreement, and finds that the Project and the Loan pursuant to the proposed Agreement are in the best interests of the City and the health, safety, morals and welfare of its residents, and in accord with the public purposes and provisions of applicable state and local law and requirements; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of City of San Diego, as follows:

- 1. The Agency has received and heard all oral and written objections to the proposed Rehabilitation Loan Agreement, and all such oral and written objections are overruled.
- 2. The Agency finds and determines that the Loan to be provided under the Agreement is in an amount necessary to effectuate the purposes of the Redevelopment Plan for the Project Area.
- 3. The Agency approves the Agreement, which establishes the terms and conditions for the Loan and implementation of the Project.
- 4. The Agency authorizes the Executive Director of the Agency, or designee, to execute the Agreement on behalf of the Agency; a copy of the fully-executed Agreement shall be placed on file in the office of the Agency Secretary as Document No. D-
- 5. The Agency authorizes the Executive Director of the Agency, or designee, to sign all documents necessary and appropriate to carry out and implement the Agreement and to administer the Agency's obligations, responsibilities and duties to be performed under the Agreement on behalf of the Agency.

- 6. The Agency authorizes the City Comptroller to establish an appropriation in the amount of \$500,000 designated as the "3029 University Avenue Rehabilitation Project" through the transfer of \$500,000 from "North Park Unallocated Funds".
- 7. The Agency authorizes the City Comptroller to expend non-housing tax increment funds derived from the Project Area, in an amount of up to \$500,000, toward the "3029 University Avenue Rehabilitation Project" as a forgivable loan to Borrower for the Project.
