- That the Ad Hoc Committee of the Redevelopment Agency (Committee) is
  hereby renewed for a period of one year, and shall be automatically terminated on
  December 13, 2012, unless renewed by the Agency.
- 2. That the Committee shall be composed of four voting board members of the Agency, the appointments to be as follows:

BE IT FURTHER RESOLVED that the establishment and renewal of the Ad Hoc Committee is a matter that is exclusively within the purview of the members of the Agency and is therefore not subject to the veto authority of the Mayor as set forth in the Agency bylaws.
