A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING MARINA DEVELOPMENT PERMIT 98-0360, INCLUDING THE BASIC CONCEPT/SCHEMATIC DRAWINGS AND REQUESTED EXCEPTIONS WITHIN THE CENTRE CITY REDEVELOPMENT PROJECT AREA.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Centre City Redevelopment Project (the "Project"); and

WHEREAS, in order to carry out and pursuant to the Plan, The Olson Company (the "Developer") has submitted to the Agency Marina Development Permit 98-0360 for the Olson Marina Housing Project (the "Development"), a 109-unit residential condominium project located on the full block bounded by Market Street, State Street, G Street, and Union Street; and

WHEREAS, pursuant to the Marina Planned District Ordinance ("PDO"), the Developer has submitted to the Agency the Basic Concept and Schematic Drawings for the Development; and

WHEREAS, pursuant to the Marina Planned District Ordinance, the Developer has applied for certain Exceptions in order to permit the development as shown on the Basic Concept/Schematic Drawings; and

WHEREAS, the Basic Concept/Schematic Drawings and the proposed Exceptions have been reviewed by the Centre City Redevelopment Project Area Committee; and

WHEREAS, the Centre City Development Corporation, Inc., and the Agency have held

public hearings to consider the proposed Permit and Exceptions, having duly published and

mailed notice of such public hearings and permitted interested citizens and area residents to

review and comment on the proposed Development; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as

follows:

1. That Marina Development Permit 98-0360, including the Basic

Concept/Schematic Drawings and requested Exceptions, is hereby granted subject to the

conditions stated in Exhibit A attached hereto and incorporated herein by this reference.

2. That the Agency hereby approves the Exceptions as stated in Exhibit B attached

hereto and incorporated herein by this reference, based on the reasons (findings) stated in the

staff report dated December 7, 1998, for the project, incorporated herein by this reference.

3. That the approval hereunder of the Basic Concept/Schematic Drawings with the

stated Exceptions shall constitute a Conditional Planned District Permit pursuant to the Marina

PDO regulations (San Diego Municipal Code section 103.2004(C)(5)).
