WHEREAS, the Redevelopment Agency of The City of San Diego
(the "Agency") has prepared a proposed amendment (the
"Amendment") to the Redevelopment Plan for the Gaslamp Quarter
Redevelopment Project; and

WHEREAS, the Agency submitted the proposed Amendment to the Planning Commission of The City of San Diego for its report and recommendation, and the Planning Commission by Resolution No. 5339 on December 6, 1984, reviewed the proposed Amendment and recommended the approval and adoption of the proposed Amendment; and

WHEREAS, pursuant to Section 33352 of the Community

Redevelopment Law of the State of California (Health and Safety

Code Section 33000, et seq.), the Agency has prepared a Report to
the Honorable Mayor and City Council on the proposed Amendment;
and

WHEREAS, Section 33458 of the Community Redevelopment Law authorizes a joint public hearing on the proposed Amendment with the consent of the Agency and the City Council; NOW, THEREFORE, BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

- 1. That the Agency hereby approves and adopts the Report to Honorable Mayor and City Council on the proposed Amendment, attached hereto as Exhibit A and incorporated herein by reference, and hereby submits said Report together with the proposed Amendment to the City Council.
- 2. That the Agency hereby consents to a joint public hearing on the proposed Amendment on Tuesday, January 8, 1985, at 10:30

a.m., in the City Council Chambers to consider and act upon the proposed Amendment and all documents and evidence pertaining thereto.
