RESOLUTION NO. 1372  
ADOPTED ON JULY 1, 1986

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION TO CHANGE THE SCOPE OF WORK AND AMEND THE BUDGET FOR CONSTRUCTION OF SEWER LINES IN BROADWAY, INDIA AND COLUMBIA STREETS, IN THE COLUMBIA REDEVELOPMENT PROJECT AREA.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has directed that redevelopment activity should occur on Parcel C, between Kettner Boulevard, Broadway and State Street, in the Columbia Redevelopment Project area (the "Project"); and

WHEREAS, the Agency did direct the clearance of the site by removing utility lines that might restrict construction on the site and did so by adopting Resolution No. 1256 on January 14, 1986; and

WHEREAS, it has been determined that there would be an increase in efficiency and a cost savings to both the Agency and the City's Water Utility Department if the scope of work specified in Resolution No. 1256 be expanded to included construction of sanitary sewer lines in both India and Columbia Streets and those lines be attached to the Broadway sewer line; and

WHEREAS, the City's Water Utility Department has agreed to participate in this expansion of the scope of work by paying that portion of the work to construct sewer lines in India and Columbia Streets; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. That the Centre City Development Corporation is hereby authorized to amend the scope of work of subject contract identified in Resolution No. 1256 by adding sewer lines in India

and Columbia Streets for a distance of approximately 300 feet north of Broadway for each street and by amending the budget for such work by including that portion of the City's Water Utility Department's share, approximately \$163,330.00.

2. That the Executive Director of the Agency, or his designee, is hereby authorized to award the contract to the lowest responsible qualified bidder provided said bids are within the established budget for construction of these utility lines.

3. That the expenditure shall not exceed a project total of \$213,386.00 from the Project Fund (Auditor Certificate No. 85542) and \$163,330.00 from the City's Water Utility Department's Capital Improvement Project for the construction of said public improvements.

4. That the Centre City Development Corporation is hereby authorized, on behalf of the Agency and the City's Water Utility Department, to administer said contract.
