A RESOLUTION OF THE REDEVELOPMENT AGENCY OF
THE CITY OF SAN DIEGO APPROVING THE BASIC
CONCEPT DRAWINGS AND THE ARCHITECT, LANDSCAPE
ARCHITECT AND CIVIL ENGINEER FOR THE
DEVELOPMENT OF CLEAN LIGHT-INDUSTRIAL
FACILITIES WITHIN THE GATEWAY CENTER EAST
DEVELOPMENT OF THE MOUNT HOPE REDEVELOPMENT
PROJECT BY STARBOARD DEVELOPMENT COMPANY.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Mount Hope Redevelopment Project (the "Project"); and

WHEREAS, in order to carry out and implement such Redevelopment Plan, the Agency has approved a Disposition and Development Agreement (the "Agreement") with Starboard Development Company (the "Developer") which provides for the development of clean, light-industrial facilities within the Project area; and

WHEREAS, pursuant to the Agreement, the Developer has submitted to the Agency the basic concept drawings pertaining to the development of the clean, light-industrial facilities and has selected an architect, landscape architect and civil engineer for the development; and

WHEREAS, the basic concept drawings have been reviewed and recommended for approval by the Southeast Economic Development Corporation, Inc., and the Planning Commission of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, that the basic concept drawings submitted by the

Developer are hereby approved. A copy of said drawings are on file in the office of the Secretary to the Agency as Document No. 1285.

BE IT FURTHER RESOLVED, that, as provided for in the Disposition and Development Agreement entered into by and between Starboard Development Company, and the Agency on November 26, 1985, and filed with the Secretary to the Agency as Document No. 1284, the firm of HCH & Associates is hereby approved as architect and civil engineer and the firm of Van Dyke & Associates is hereby approved as the landscape architect for the proposed development by the Developer at Gateway Center East in the Project.
