RESOLUTION NO. 1695
ADOPTED ON FEBRUARY 7, 1989

A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE BASIC CONCEPT (INCLUDING SCHEMATIC) DRAWINGS WITH RESPECT TO THE CONSTRUCTION OF A MIXED USE DEVELOPMENT WITHIN THE MARINA REDEVELOPMENT PROJECT AREA BY CHARLES P. TYSON AND MILTON FREDMAN, SUBJECT TO THE CONDITIONS STATED HEREIN, AND APPROVING CERTAIN EXCEPTIONS TO THE MARINA PLANNED DISTRICT REGULATIONS IN CONNECTION THEREWITH.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Marina Redevelopment Project (the "Project"); and

WHEREAS, in order to carry out and implement such Redevelopment Plan, the Agency has approved a Negotiation Agreement (the "Agreement") with Charles P. Tyson and Milton Fredman (the "Developer") which provides for the construction of a mixed use development within the Project area; and

WHEREAS, pursuant to the Agreement the Developer has submitted to the Agency the Basic Concept (including Schematic) Drawings pertaining to the development; and

WHEREAS, pursuant to Section 103.2007 of the Marina Planned District (Chapter X, Article 3, Division 20 of the San Diego Municipal Code) the Developer has applied for certain exceptions to the Marina Planned District regulations in order to permit the development as shown on the Basic Concept (including Schematic) Drawings; and

WHEREAS, the Basic Concept (including Schematic) Drawings and the proposed exceptions to the Marina Planned District regulations have been reviewed by the Centre City Development Corporation Residents Advisory Committee; and

WHEREAS, pursuant to Section 103.2007 of the Marina Planned District regulations the Centre City Development Corporation, Inc. and this Agency have held public hearings to consider the proposed exceptions, having duly published and mailed notice of such hearings, and permitted interested citizens and area residents to review and comment on the proposed development; and

WHEREAS, the Basic Concept (including Schematic) Drawings and the proposed exceptions to the Marina Planned District regulations have been reviewed and recommended for approval by the Centre City Development Corporation, Inc. and the Planning Commission of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. That the Basic Concept (including Schematic) Drawings submitted by the Developer are hereby approved, subject to the conditions stated in Exhibit A, attached hereto and incorporated herein by this reference.

2. The Agency hereby approves the exceptions to the Marina Planned District regulations as stated in Exhibit B, attached hereto and incorporated herein by this reference, for the reasons stated in Exhibit B.

3. The approval hereunder of the Basic Concept (including Schematic) Drawings, with the stated exceptions, shall constitute a Conditional Planned District Permit pursuant to Section 103.2003 C.5. of the Marina Planned District regulations.
