RESOLUTION NO. 1848
ADOPTED ON MARCH 20, 1990

RESOLUTION OF THE REDEVELOPMENT AGENCY
APPROVING THE CONFLICT OF INTEREST CODE FOR
REDEVELOPMENT PROJECT COMMITTEES.

WHEREAS, California Health and Safety Code section 33385 requires the formation of a Project Area Committee ("PAC") in a redevelopment project area within which a substantial number of low- and moderate-income families are to be displaced by a redevelopment project; and

WHEREAS, if a substantial number of low- and moderate-income families are not to be displaced, California Health and Safety Code section 33385 allows for the formation of a PAC to provide community input in the establishment of a redevelopment project; and

WHEREAS, the Fair Political Practices Commission has determined that PACs are subject to the disclosure and disqualification provisions of the Fair Political Practices Act (California Government Code section 81000 et seq.); and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, 2 Cal. Code of Regulations section 18730, which contains the terms of a standard conflict of interest code; and

WHEREAS, this standard code can be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of San Diego, that the terms of 2 Cal. Code of Regulations section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference (Attachment A) and, along with the attached Appendix in which members and employees are designated and disclosure categories are set forth, constitute the conflict of interest code of the Redevelopment Project Area Committees.

BE IT FURTHER RESOLVED, that pursuant to Section 4(A) of the standard code, designated employees shall file statements of economic interests (SEI's) with the Secretary of the Redevelopment Agency of San Diego.

BE IT FURTHER RESOLVED, that upon receipt of the SEI's of the PAC members and chair, the Secretary of the Redevelopment Agency of San Diego shall retain the originals.

BE IT FURTHER RESOLVED, that this conflict of interest code shall become effective upon the date of approval by the Redevelopment Agency of San Diego and PAC members shall file their SEI's within thirty (30) days of receipt of this code as documented in their meeting minutes.
