A RESOLUTION OF THE REDEVELOPMENT AGENCY OF
THE CITY OF SAN DIEGO AMENDING THE RULES AND
REGULATIONS FOR IMPLEMENTATION OF THE
CALIFORNIA RELOCATION ASSISTANCE LAW.

WHEREAS, the Redevelopment Agency of The City of San Diego, California ("Agency"), is engaged in activities necessary to carry out and implement the redevelopment plans for various redevelopment projects; and

WHEREAS, in order to carry out and implement such redevelopment plans, Agency has executed disposition and development agreements providing for the sale of real properties in the redevelopment projects; and

WHEREAS, the real properties acquired by Agency contain persons, families and businesses which will or may be displaced as a result of the implementation of the development activities proposed in the disposition and development agreements; and

WHEREAS, the State of California adopted Government Code section 7260 et seq. (the "Code") which sets forth rules and regulations to implement California Relocation Assistance Law; and

WHEREAS, the Code can be incorporated by reference and may be amended by the State of California after public notice and hearings; and

WHEREAS, Agency has adopted a relocation plan (the "Plan") providing for the relocation of such displaced persons, families and businesses, and relocation rules and regulations for implementation of the California Relocation Assistance Law for Agency (the "Rules"), of which Plan and Rules are on file in the office of the Secretary of Agency as Document No. 481 and Document No. 482, respectively; and

WHEREAS, the State of California amended the Code on January 1, 1990, which necessitates revision of Agency's Rules;

and

WHEREAS, Agency desires to revise its Rules so as to conform with this change in state law; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. Agency hereby amends Agency Rules and Regulations for Implementation of the California Relocation Assistance Law as set forth in Document No. 1729 on file in the office of the Secretary to the Agency.

2. Any amendments of Government Code sections 7260 et seq. duly adopted by the State of California are hereby incorporated by reference.

3. The Executive Director, or his designee, is hereby authorized and directed to develop implementation procedures and guidelines regarding the amended Rules.
