RESOLUTION NO. 2380
ADOPTED ON APRIL 26, 1994

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego (the "Agency"), as follows:

- 1. That it hereby authorizes and accepts the transfer of one hundred thousand dollars (\$100,000) of excess TransNet funds from the completed Imperial Avenue I Improvements Project (CIP #39-252.0, Fund #98771) to the Ozark Street I-Public Improvements Project (CIP #39-255.0, Fund #98774).
- 2. That the Agency Fiscal Year 1994 budget be amended to deduct one hundred thousand dollars (\$100,000) of TransNet funds from the Imperial Avenue I Improvements Project (CIP #39-252.0, Fund #98771) and to add these funds to the Southeastern Economic Development Corporation's ("SEDC") Ozark Street I-Public Improvements Project (CIP #39-255.0, Fund #98774).
- 3. That it authorizes the transfer from the Agency to The City of San Diego (the "City") of two hundred thousand dollars (\$200,000) of Capital Outlay funds from the Ozark Street I-Public Improvements Project (CIP #39-255.0, Fund #98774) to the Bay Terraces Community Park Project (CIP #29-810.0).
- 4. That the Agency Fiscal Year 1994 budget be amended to deduct two hundred thousand dollars (\$200,000) of Capital Outlay funds from Ozark Street I-Public Improvements Project (CIP #39-255.0, Fund #98774).
- 5. That it authorizes the transfer from the Agency to the City of eighty thousand dollars (\$80,000) of Capital Outlay funds from the Ozark Street I-Public Improvements Project (CIP #39-255.0, Fund #98774) to the Euclid Community Resource Center (CIP #37-006.0).
- 6. That it authorizes and accepts from the City to the Agency the transfer of eighty thousand dollars (\$80,000) of Community Development Block Grant ("CDBG") funds from the Euclid Community Resource Center (CIP #37-006.0) to the Ozark Street II-Private Improvements Project (CIP #39-255.0, Fund #98774).
- 7. That it authorizes SEDC to expend up to one hundred sixty thousand dollars (\$160,000) of CDBG funds for the Ozark Street II-Private Improvements Project (Fund #98774).
