A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO ADOPTING THE CENTRE CITY EAST FOCUS PLAN FOR THE CENTRE CITY EAST REDEVELOPMENT DISTRICT OF THE EXPANSION SUB AREA OF THE CENTRE CITY REDEVELOPMENT PROJECT.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has determined that it should develop a strategy and specific actions which implement plans and programs to improve the Centre City Redevelopment Project Area in conformance with the Redevelopment Plan; and

WHEREAS, the Agency has determined that it should identify specific strategies obtained through public input for implementation which may include more specific geographical and topical "Focus Plans"; and

WHEREAS, the Centre City East Focus Plan establishes goals and objectives and policies for the use of Agency funds, and describes initial projects; and

WHEREAS, the Centre City East Focus Plan has been complemented by "A Vision for Centre City East," a concept plan prepared by Dean Adele Santos of the University of California utilizing the talents of multi-disciplined design professionals and extensive citizen input as a guide for the future development of Centre City East; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

- 1. That the Centre City East Focus Plan is hereby adopted;
- 2. That the Centre City Development Corporation ("Corporation"), on behalf of the Agency, is hereby authorized to implement the Centre City East Focus Plan;
- 3. That the document "A Vision for Centre City East," prepared by Dean Adele Santos of the University of California, is hereby incorporated as an appendix to the Centre City East Focus Plan, to be

used as a guide for the implementation of the Centre City Redevelopment Plan in the Centre City East area; and

- 4. That the concepts contain in "A Vision for Centre City East" are hereby endorsed; and
- 5. That the Corporation is hereby directed to proceed with refinements to "A Vision for Centre City East" including:
 - a. A process for involving the community and technical resources;
 - b. An evaluation of the physical feasibility and costs of implementing the concepts contained in the Visions statement; and
 - c. Options or alternatives for specific concepts.
