A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO ACCEPTING A TOTAL OF \$5,400 IN FUNDS FROM THE CITY OF SAN DIEGO'S COMMISSION FOR ARTS AND CULTURE AND AN ANONYMOUS DONATION, AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE THE CONTRACT SERVICE AGREEMENT FOR THE "TIERRA ALTA HERITAGE ARTS PROGRAM" FOR "AT-RISK" YOUTHS IN THE CITY HEIGHTS REDEVELOPMENT PROJECT, AND APPROVING AN AMENDMENT TO THE FY 1995 AGENCY BUDGET.

WHEREAS, City Heights Redevelopment Plan objectives include stabilizing the community "by improving the quality of life and vitality of the community through such action plans as" the promotion of cultural programs which reflect the area's ethnic diversity and supporting projects that meet the special needs of "at-risk" local children; and

WHEREAS, the Commission for Arts and Culture through the FY 95 Neighborhood Arts Program is facilitating arts programs to provide opportunity for community identity, sources of pride, artistic expression and cultural diversity to "at-risk" youth in eight communities identified in the City's Neighborhood Pride and Protection Plan, and has selected the City Heights Redevelopment Project Area as one of the eight sites for the "Tierra Alta Heritage Arts program"; and

WHEREAS, the Commission for Arts and Culture and an anonymous matching donation is providing funding for a total amount of \$5,400 to accomplish the "Tierra Alta Heritage Arts Program for "at-risk" youths including art workshops, an art installation and reception through a contract service agreement with the Commission for Arts and Culture; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San

Diego, as follows:

- 1. That the Redevelopment Agency hereby authorizes the acceptance of a grant of \$2,400 from the Commission for Arts and Culture and an anonymous donation of \$3,000 for the Tierra Alta Heritage Arts Program.
- 2. That the Executive Director, or designee, is hereby authorized and empowered to execute, for and on behalf of the Agency, a service contract agreement with the City of San Diego's Commission for Arts and Culture, for two thousand four hundred dollars (\$2,400), under the terms and conditions of the agreement on file in the office of the Secretary to the Agency as Document No. 02216.
 - 3. That the Agency budget be amended to reflect this action.
- 4. That the Mid-City Development Corporation, on behalf of the Agency, is hereby authorized to administer the service contract agreement for the subject property.
