A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE PROPOSED REDEVELOPMENT PLAN FOR THE SAN YSIDRO REDEVELOPMENT PROJECT, APPROVING THE REPORT TO THE CITY COUNCIL (INCLUDING THE IMPLEMENTATION PLAN) PERTAINING THERETO, AND AUTHORIZING SUBMISSION OF THE PROPOSED REDEVELOPMENT PLAN AND THE REPORT TO THE CITY COUNCIL, TO THE COUNCIL OF THE CITY OF SAN DIEGO.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has prepared a proposed Redevelopment Plan for the San Ysidro Redevelopment Project (the "Project"); and

WHEREAS, the proposed Redevelopment Plan conforms to the requirements of the California Community Redevelopment Law (Health and Safety Code section 33000 et seq.); and

WHEREAS, after due notice as provided by the California Community Redevelopment Law, a joint public hearing was held by the Agency and the Council of The City of San Diego (the "Council") to consider the proposed Redevelopment Plan; and

WHEREAS, the Agency intends to submit the proposed Redevelopment Plan for the San Ysidro Redevelopment Project to the Council for consideration of its approval and adoption; and

WHEREAS, the proposed Redevelopment Plan, when submitted by the Agency to the Council, shall be accompanied by a report containing the information provided for in Section 33352 of the California Community Redevelopment Law; and

WHEREAS, the Agency has prepared the Report to City Council on the San Ysidro Redevelopment Project, including without limitation the Implementation Plan for the San Ysidro Redevelopment Project; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. That the proposed Redevelopment Plan for the San Ysidro Redevelopment Project is hereby approved.

2. That the Agency hereby recommends that the proposed Redevelopment Plan for the San Ysidro Redevelopment Project be approved and adopted by the Council.

3. That the Report of the Agency to the Council on the proposed San Ysidro Redevelopment Project, including without limitation the Implementation Plan for the San Ysidro Redevelopment Project, is hereby approved.

4. That the Executive Director of the Agency, or designee, is hereby authorized and directed to submit the proposed Redevelopment Plan for the San Ysidro Redevelopment Project, to the Council.

5. The Executive Director of the Agency, or designee, is hereby further authorized and directed to submit the Report of the Agency to the Council on the proposed San Ysidro Redevelopment Project, to the City Council.
