A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO ACCEPTING \$2,970 IN FUNDS FROM THE CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PROTECTION, RATIFYING A GRANT AGREEMENT FOR A TREE-PLANING PROJECT IN THE CITY HEIGHTS REDEVELOPMENT PROJECT, AND APPROVING AN AMENDMENT TO THE FISCAL YEAR 1996 AGENCY BUDGET.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has determined that it should encourage development in the City Heights Redevelopment Project; and

WHEREAS, the City Heights Redevelopment Plan objectives include eliminating blighting influences and improving the environment and vitality of the community by enhancing the streetscape aesthetics of the area; and

WHEREAS, the Mid-City Development Corporation ("MCDC") is responsible for carrying out redevelopment activities within the City Heights Redevelopment Project Area (the "Project Area"), pursuant to an Operating Agreement with the Agency, on file in the office of the Secretary to the Agency as Document No. 01921; and

WHEREAS, the Department of Forestry and Fire Protection (the "Department") is facilitating various community volunteer tree-planting activities throughout California, and has selected an area within the Project Area as a site for a fifty (50) tree planting project; and

WHEREAS, the Department has provided funding in the amount of two thousand nine hundred seventy dollars (\$2,970) to purchase, mulch, and stake the trees through a grant agreement with California ReLeaf, a program of the Trust for Public Land; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. That the Agency hereby ratifies the application and

acceptance of a grant by MCDC in the amount of two thousand nine hundred seventy dollars (\$2,970) from the Department of Forestry and Fire Protection, for a tree planting project in the City Heights Redevelopment Project Area.

- 2. That the Agency hereby ratifies the execution of a grant agreement by the Redevelopment Manager of MCDC, with California ReLeaf, a copy of that grant agreement being on file in the office of the Secretary to the Agency as Document No. 02574.
- 3. That the Fiscal Year 1996 Agency Budget be amended to reflect this action.
- 4. That MCDC is hereby authorized to administer the tree-planting project on behalf of the Agency.
