A RESOLUTION OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO APPROVING THE REPORT TO THE CITY COUNCIL ON THE PROPOSED SECOND AMENDMENT TO REDEVELOPMENT PLAN FOR THE CENTRAL IMPERIAL REDEVELOPMENT PROJECT, AND AUTHORIZING SUBMISSION OF THE PROPOSED SECOND AMENDMENT, AND THE REPORT TO THE CITY COUNCIL.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") has prepared a proposed Second Amendment to Redevelopment Plan for the Central Imperial Redevelopment Project (the "Project"); and

WHEREAS, the proposed Second Amendment to Redevelopment Plan conforms to the requirements of the California Community Redevelopment Law (California Health and Safety Code section 33000 et seq.) and

WHEREAS, the Agency intends to submit the proposed Second Amendment to Redevelopment Plan to the Council of The City of San

Diego (the "Council") for consideration of its approval and adoption; and

WHEREAS, the Second Amendment to Redevelopment Plan, when submitted by the Agency to the Council, shall be accompanied by a report containing the information provided for in Sections 33457.1 and 33352 of the California Community Redevelopment Law; and

WHEREAS, the Agency has prepared the Report of the Redevelopment Agency to the City Council on the Second Amendment to Central Imperial Redevelopment Plan, which shall be supplemented with certain pertinent information as it is received and/or compiled; NOW, THEREFORE,

BE IT RESOLVED, by the Redevelopment Agency of The City of San Diego, as follows:

1. That the Report of the Redevelopment to the City Council on the Second Amendment to the Central Imperial Redevelopment Plan is hereby approved. The Executive Director of the Agency (or designee) is hereby authorized and directed to supplement the Report with such pertinent information as may be received and/or compiled prior to the joint public hearing of the Agency and the Council on the proposed Second Amendment to Redevelopment Plan.

2. That the Executive Director of the Agency (or designee) is hereby authorized and directed to submit the proposed Second Amendment to Redevelopment Plan for the Central Imperial Redevelopment Project, to the Council.

3. That the Executive Director of the Agency (or designee) is hereby further authorized and directed to submit the Report of the Redevelopment Agency to the City Council on the Second Amendment to the Plan, including any pertinent supplemental information, to the Council.
